

## CUSTOMER SERVICE ADVICE FROM TELSTRA

### **Delay due to fire in parts of the Mid North Coast District of New South Wales.**

Parts of the Mid North Coast District of New South Wales were impacted by bushfires during November 2019 through to December 2019 and are ongoing to date. These events resulted in extensive damage to Telstra's telecommunications network. In some cases, unsafe conditions and road closures are preventing us from reaching these locations but we will attend as soon as these areas are deemed safe.

An interruption to Telstra's normal operations has occurred leading to delays in installation and repair activities. As many as 200 Telstra services are impacted in the area bounded by and including, but not limited to, the area starting at Diamond Head following the NSW coast south past Crowdy Head and Forster to Green Point. The area turns northwest to Krumbach, north to Kundibakh then northwest to Caffreys Flat. From Caffreys Flat the area heads northeast to Innes View, east to Swans Crossing then southeast back to Diamond Head. All suburbs and towns, off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

### **How will this affect you?**

Unfortunately your service may be affected and we may take longer than normal to fix telephone services or complete connections. Services in the area mentioned above with phone numbers in the following number ranges may have been affected:

We anticipate that the majority of services will be restored by 31 December 2019. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

Due to this event, we're claiming an exemption under section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011, including an exemption from the payment of compensation between **11 December 2019 to 31 December 2019** inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.
