

## CUSTOMER SERVICE ADVICE FROM TELSTRA

### **Delay due to fire in parts of the Hawkesbury region and Hunter and Central Tablelands Districts of New South Wales.**

Parts of the Hawkesbury region and Hunter and Central Tablelands Districts of New South Wales were impacted by bushfires during November 2019 through to December 2019 and are ongoing to date. These events resulted in extensive damage to Telstra's telecommunications network. In some cases, unsafe conditions and road closures are preventing us from reaching these locations but we will attend as soon as these areas are deemed safe.

An interruption to Telstra's normal operations has occurred leading to delays in installation and repair activities. As many as 200 Telstra services are impacted in the areas bounded by and including, but not limited to, the area starting at Belford, the area travels south to Paxton then turns southeast to Cooranbong, southwest to Kulnar, northwest to Perrys Crossing and south to Wisemans Ferry. At Wisemans Ferry the area continues southwest past Wheeny Creek, Grose Vale, Wentworth Falls to Gingkin. At Gingkin the area turns northeast to Clarence, north to Wolgan Valley, northeast to Mellong and travels north along Putty Road to Milbrodale, and east back to Belford, and the area starting at Capertee, heading southwest to Yetholme, northwest to Peel, northeast to Sofala before heading southeast returning to Capertee. All suburbs and towns serviced by Telstra within these boundaries are encompassed in this exemption.

#### **How will this affect you?**

Unfortunately your service may be affected and we may take longer than normal to fix telephone services or complete connections. Services in the area mentioned above with phone numbers in the following number ranges may have been affected:

We anticipate that the majority of services will be restored by 19 January 2020. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

Due to this event, we're claiming an exemption under section 21 of the Telecommunications (Customer Service Guarantee) Standard 2011, including an exemption from the payment of compensation between **16 December 2019** to **19 January 2020** inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.
